FOXES TRUST

- Is a non-profit making Supporters Trust.
- Membership is open to **all** fans of Leicester City Football Club.
- Is **totally** independent of Leicester City Football Club.
- Is democratic. On a one member one vote basis.
- Roles are undertaken on a voluntary basis. Committee members are democratically elected.
- Believes the Directors and Chairman of Leicester City Football Club should act in the best interests of the community that the club serves.

FOXES TRUST – AIMS

- To lobby, publicise and campaign to encourage the Board to take into account the interests of supporters when making its decisions.
- To create an independent forum to raise the concerns of Leicester City Football Club supporters.
- To enable a democratically elected director representing the views of the supporters to influence the decision making of the board, and to enshrine in the football club's Memorandum and Articles of Association the representation of the Trust on the Board.
- To raise money for the benefit of the club. Funds raised are to be used appropriately as to benefit the best interests of Leicester City Football Club and its supporters.
- To strengthen the bonds between Leicester City Football Club and the community which it serves and to represent the interests of the community in the running of the club.
- To ensure the club meets the highest standards of business management.
- To promote, develop and respect the rights of members of the community served by the club and the Trust.
- To encourage the club to play competitive football at the highest possible level.

THE FOXES TRUST IS

- NOT a Supporters Club. Foxes Trust and the Supporters Club will co-exist, with each having a distinct and important role to play.
- NOT a protest group but a positive force for change.

SUPPORTERS' TRUSTS

- Have been set up at over 60 football clubs. 34 have a shareholding, 26 have Board representation, six Trusts run their club on a day-to-day basis.
- Can have a REAL influence on the decision making process at a club.
- Enable fans to work together as part of a democratic organisation.
- Have strong links with the community that a football club serves.

1. Terms and Conditions

1. Any contribution made (whether in the form of the annual subscription or donations of money) is not a financial investment, and cannot be refunded to the member once the transfer has been made.
2. The member will receive one share only and will be entitled to one vote per resolution raised at any general meeting. The share issued to the member is not transferable to any other person, firm or corporate body.
3. Any contribution received by the Trust from a member will be held in common for the benefit of all members and will be used to meet the objectives of the Trust.
4. As a non-profit making organisation, no financial return, whether in the form of interest or a distribution of profits, will be made to its members.
5. On winding up or dissolution of the Trust, any surpluses will be transferred to a sporting charity or charities within the area and/or one of more societies established for the benefit of the community.
6. The data contained on this application form will be held, analysed and used by the Trust Board and Executive Board solely for the purposes of the Foxes Trust, and this data may be transferred to electronic media such as a database. As defined in the Rules of the Trust, prescribed data on members will be publicly available at the Trust's registered office.
