2	Approval of Minutes 18/05/2026 - Approved No matters arising. Confirmed to publish to website.		
3a	LCFC & FAB BT outlined discussions which had taken place over recent FAB statements and published minutes. Discussion was held around the quality of the statement released and the manner of which it was shared by the football club. General disappointment with the lack of direct communication channel resulting in FAB comms being hidden. Discussion around whether FAB minutes were a fair reflection of what took place due to the exclusion of speed of meeting minutes being published and published action points. Season Ticket renewals, being as low as they were, outlines a general issue amongst the fan base and an opportunity to understand reasons for non-renewal whilst also an opportunity to truly engage with new Season Ticket holders, particularly the significant increase in under-18s. JB asked for the FAB to push for analysis on non-renewals.	BT	
4a	LCFC Dialogue & Engagement Head of Fan Engagement Vacancy LW outlined that the departure of current Head of FE was officially communicated at 2 hours' notice, representative of general approach to fan engagement. The Football Club could and should have communicated this better. FT EOSS, Feedback & Next Steps Board discussed satisfaction with the launch of the EOSS results and the way in which these were presented. Results were well received on social media with the overall communication being strong. JB & LW met with club representatives, prior to the public launch, and discussed calls to action and ways forward. The FT would like to meet formally with Club leadership, beyond usual communication channels, to discuss calls to action.		

	FEF Review FT to share whitepaper with the Football Club covering a recommended refresh of Fan Engagement Framework. Agreement that this will be shared publicly in due course once they have had time to review. Recognition there may be a delay due to current Head of FE vacancy.
